## Memorandum of Understanding for Academic Cooperation



Between

This MEMORANDUM OF UNDERSTANDING is made on (DATE) 29-09-2022 between

- Faculty of Arts, Government Shivnath Science College, Rajnandgaon, Chhattisgarh a higher education institution, acting by its Principal Dr. (Smt) Suman Singh Baghel.
- And
- Faculty of Arts, Indira Kala Sangit Vishwavidyalaya, Khairagarh, Chhattisgarh, acting by its Dean, Faculty of Arts, Professor I.D. Tiwari.

Together called "the parties"

**CONSIDERING** that the general mission of the MoU is to provide the opportunity to pursue artistic knowledge, to strengthen human resources in the field of arts, to enhance skills and quality of creative output of learners and artists, to revive and develop traditional artistic talents at national and international levels, and to foster research, document, archive and disseminate information of various forms of performing and visual art forms.

**CONSIDERING** that the vision of the Indira Kala Sangit Vishwavidyalaya, Khairagarh is to create a holistic learner centric, research oriented environment for our students, which should liberate their creativity and ignite their true spirit to pursue excellence in the field of Music and Fine Arts. To establish University as a shrine, for all the art disciples and community;

**CONSIDERING** that the vision of the Government Shivnath Science College, Rajnandgaon, CG is to provide quality education to the students of rural and tribal belt in the surrounding areas and to develop skills in students by keeping balance between the traditional human values and the new global challenges.

**CONSIDERING** the objective of the MoU is to provide and develop higher education in the branches of learning of visual and performing Arts and for advancing these art forms to attain excellence with respect to their wide dimensions of aesthetic and applied forms.

**CONSIDERING** further that the parties share substantial areas of common interest of substantial contribution towards academic and national development.

AWARE of the benefits that would flow from the closer cooperation between the parties in terms of the attainment and effectiveness of their respective academic & research programmes and also attainment of their common objectives as listed above and

DESIROUS of enhancing coordination of their work and strengthening cooperation, especially on programmes & research activities that promote sustainable development for both; whereas:

- A. The parties are both reputable provider of higher education.
- B. The Parties wish to explore the potential for the mutual enhancement of their relationships including discussion and cooperation aimed at progressive areas of joint working as described below:

**It is understood that:**

The Parties acknowledge each other's integrity, discretion and standing in respect of the students, academic matters and proper processes relating to their individual institutions. The Parties expect to conduct initial discussion through Principal, on behalf of Government Shivnath Science College and Dean, Faculty of Visual Arts on behalf of IKSVM whilst acknowledging that all formal negotiations and proposals relating to specific students and specific programmes must be conducted subject to the Parties' own proper procedures and approvals including by senior management.

The parties will invite each other's representative to meetings and conferences in accordance with the respective Rules of procedure governing such meetings and conferences, when issues of common interests to the two parties are to be discussed. The Parties wish to record that they expect to explore collaborative activity in the following areas:

- a) Knowledge Transfer in subject areas of mutual interest
- b) Collaborative research projects, and
- c) The mutual provision of services in respect of matters likely to include staff development, teaching learning programme support, joint workshops/seminars, training, projects, researches, exchanges, other educational events, to be considered by the Parties with respect to the following specific areas:
  - i. Linguistic Subjects; English and Hindi
  - ii. Ancient Indian History, Culture and Archaeology
  - iii. Cultural Studies
  - iv. Drama/ Cinema/ Television
  - v. Fostering Research & Development activities in all forms of arts
  - vi. Empowering interdisciplinary aspects in all forms of arts

This Memorandum of Understanding shall remain valid for a period of two (2) years from the date on which it is made. The Memorandum of Understanding may be extended, subject to review, by mutual agreement of the Parties

The provisions of this MOU may be amended at any time by mutual consent in writing. Either Party may terminate this Memorandum of Understanding after giving the other party three (3) months' written notice of its intention to do so.

Neither Party may use the name or logo of the other Party without the prior written consent of that other Party and neither Party shall represent to any third Party that the Parties have a legal relationship until there is a signed contract between the Parties in place.

This Memorandum of Understanding is neither intended to place legally binding obligations on either party nor to give either party any authority to act on behalf of or to commit any expenditure by the other party.

No damages of any nature can be claimed by either of the party for non-fulfilment of any conditions of this MoU.

- (c) Any Party may terminate this MOU and any related agreement for any reason by giving Thirty (30) days prior written notice to the other Party.


